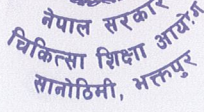



Criteria for selection and list of government medical and dental colleges are enclosed for reference. All submitted academic documents must be attested by the Ministry of Education and Ministry of Foreign Affairs of the Government of Nepal.

The esteemed Ministry is also requested to ensure that only the candidates selected by the Government of Nepal are issued with the "No Objection Certificate (NOC)" from the Nepal Medical Council for admission into government medical/dental colleges in Bangladesh.

**MBBS/BDS Admission Circular for Foreign Students in Government Medical Colleges/
Dental College/ Dental units of Bangladesh (Session 2024-2025)**

Please be informed that the Directorate General of Medical Education under Medical Education & Family Welfare division of Ministry of Health and Family Welfare, Bangladesh has announced admission of foreign students in Government Medical Colleges and Dental College Units for the academic year 2024-2025. Total 221 seats are allocated for the foreign students in this year. Among these, 117 seats are allocated for SAARC countries, 99 seats are allocated for Non-SAARC countries and 5 reserved seats under Bangladesh Government's scholarship program. Country-wise allocation of seats are as follows:



02. The Ministry of Health and Family Welfare of Bangladesh will consider application of foreign students for admission in Government Medical Colleges/Dental College/Dental Units in Bangladesh.
03. Interested candidates should duly fill-up an application form and arrange all necessary documents. Template of application form is enclosed at Annexure 'A'.
04. List of government medical colleges/dental college/dental units of Bangladesh is enclosed at Annexure 'B'.
05. Criteria of application for foreign students are enclosed at Annexure 'C'.
06. Interested candidates have to submit the application form attached with all academic records and relevant documents which must be sent to their respective ministry of foreign affairs/responsible authority within 15 January, 2025. No application will be considered after the deadline. Respective Ministry of foreign affairs/responsible authority of the country will verify the documents according to admission criteria mentioned in Annexure 'C' and will make an eligible list of students and send all documents to the ministry of foreign affairs of Bangladesh within 15th February 2025. The ministry of foreign affairs of Bangladesh will send the documents regarding foreign student admission to the medical education and family welfare division of the ministry of health and family welfare within 2nd March 2025.



07. Candidates have to submit recent Passport Size Photograph, Passport, all academic documents (certificate and marks sheet of 'O' level/10 class completion exam and 'A' level/12 class completion exam). All submitted academic documents should be attested by Ministry of Education and Ministry of Foreign affairs of the respective countries and must be authenticated by the Embassy of Bangladesh of the concerned country. Eligible applicants must submit the attested documents to Bangladesh mission to obtain visa.
08. The applicants must have at least aggregated GPA 9.00 (Nine) in 'O' level and 'A' level exam of individual GPA 5 (Five) scale. Applicants also must have Grade Point 4.00 in Biology (at least 70% marks) in 'A' level/12 class completion equivalent examination.
09. Detailed information of marks equalization is enclosed in Annexure 'D'.
10. All original certificates, mark sheets and relevant documents should be submitted to the office of the principal of respective government medical colleges/dental college/dental units of Bangladesh at the time of admission.
11. Admission will be continued into respective medical colleges/dental college/dental units from 15th April 2025 to 22nd May 2025. Students must follow the rules and regulations of the college, hostel and hospital authorities.
12. Fabrication of any documents in the admission process is subjected to cancelation of admission which will be punishable under law. If any information or document or procedure is found fictitious in future, the admission will be void immediately and the ministry of health & family welfare of Bangladesh will not bear any responsibility.
13. Admission policy of MBBS/BDS course 2025 by Bangladesh Medical and Dental Council (BM&DC) will be applicable.
14. The decision of admission committee (2024-2025) will be final in any matter for admission in medical colleges/dental college/units in Bangladesh.

Annex 'C'

Criteria for Admission of Foreign Students in the MBBS and BDS Courses in Government Medical Colleges/Dental College / Dental Units in Bangladesh for 2024-2025 academic year.

- A) Academic Records:
- Must have passed qualifying examination of 'O' and 'A' level or equivalent examination with science background
 - 'O' level or equivalent examination passed not before 2021
 - 'A' level or equivalent examination passed in the year of 2023/2024.
 - 'A' level or equivalent exam must be completed within 3 years of 'O' level or equivalent exam.
 - Minimum aggregated GPA in 'O' level or equivalent and 'A' level or equivalent examination is 9.00 (nine)
 - Minimum GP in Biology: 4.00 (at least 70% marks) out of 5.00 scale in 'A' level or equivalent exam
- B) For calculating GPA against the percentage of marks obtained in 'O' level or other equivalent exam only top 5 subjects are considered.
- C) For calculation of GPA against the marks obtained in 'A' level or equivalent exam, only 3 subjects (Physics, Chemistry and Biology) are considered.
- D) All certificates must be duly attested by the competent authority, i.e. Education and the Foreign Ministries of the respective countries and must be authenticated by the Embassy of Bangladesh of the concerned country.
- E) Tuition Fees: For Government medical and dental colleges, students from SAARC countries will require to pay tuition and other fees at the rate charged to a Bangladeshi student. Students from other countries will have to pay \$5000 (five thousand) per year in addition to the tuition fees charged for Bangladeshi student. If students can't pass in the exam in due time additional charges have to pay.
- F) Admission policy of MBBS/BDS course 2025 by Bangladesh Medical and Dental Council (BM&DC) will be applicable.



Equivalence & Eligibility

Equivalence: Mark sheet of 'O' level /10 class completion exam and 'A' level/12 class completion exam will be considered. For 'O' Level exam mark sheet of top 5(five) subjects will be considered and for 'A' level exam marks of Biology, Chemistry & Physics will be considered.

Preparing merit list: First of all applicant's Grade Point Average (GPA/CGPA) of 'O' level and 'A' level will be cumulated. In case of equal GPA/CGPA, individual highest grade point of Biology, Chemistry and Physics of 'A' level will be considered respectively. When the said equation will be same, then total aggregation of obtained marks of Biology, Chemistry and Physics will be considered. When the total aggregation of three subjects will be same, then the senior applicant (age according to date of birth) will get preference.
